MIGRANT EDUCATION PROGRAM (MEP) FUNDING

- FY 2020 MEP Formula Grant Awards: Approximately \$364.8 million allocated to 46 State educational agencies (SEAs) on July 1, 2020
- FY 2019 Supplemental Awards: Approximately \$1.1 million awarded to 32 eligible SEAs September 25, 2020
- FY 2021: Pending a final appropriation, we are operating under a Continuing Resolution (CR) through December 11, 2020

FY 2020 CONSORTIUM INCENTIVE GRANT (CIG) AWARDS

Approximately \$3 million awarded to 39 SEAs on September 8, 2020

- Absolute Priorities: 1) Identification and Recruitment (ID&R), 2)
 Migratory Parents, and 3) Out of School Youth (OSY)
- Competitive Preference Priorities: 1) Promoting Science, Technology, Engineering, and Math (STEM) Education, With a Particular Focus on Computer Science and 2) Promoting Economic Opportunity

Four consortia:

- 1. Identification & Recruitment Consortium (IDRC)
- 2. Migratory Parent Empowerment Consortium (MPEC)
 - Addresses competitive preference priority 1
- 3. Inspire and Innovate: the Migratory Parent Coalition (I2MPACT)
 - Addresses competitive preference priority 2
- Instructional Services for Out of school and Secondary Youth (iSOSY)
 - Addresses competitive preference priority 2

INTERSTATE COORDINATION (RESULTS) SERVICES AND WEBSITE

- The US Department of Education awarded the RESULTS Interstate Coordination Services and Website contract to RTI International on September 25, 2020.
- The contractor will be responsible for the following activities related to interstate coordination:
 - Technical assistance for intrastate and interstate coordination, including student record transfer, to the 46 States implementing the MEP
 - Support for conferences, stakeholder meetings, and the interstate coordination exchange network
 - Maintain and update the RESULTS website with resources and products related to interstate coordination

TECHNICAL ASSISTANCE AROUND INTERSTATE COORDINATION REQUESTED BY MEP GRANTEES


- Compile, develop and maintain technical assistance products and tools on RESULTS website
- Obtain highly qualified technical assistance and subject matter experts (SMEs) to work on MEP-specific resources, e.g., ID&R, parental involvement, binational topics, secondary credit accrual and graduation requirements, OSY needs, summer programming, etc.
- Develop and conduct national student record transfer needs assessment plan
- Develop and conduct State-specific student record transfer needs assessment plans and provide one-on-one technical assistance

TECHNICAL ASSISTANCE AROUND INTERSTATE COORDINATION REQUESTED BY MEP GRANTEES (CONT.)


- Develop, plan and coordinate Interstate Coordination Network where States can work with each other to provide mentorship, meet, plan and strategize on various topics of mutual interest, e.g., secondary credit accrual, MEP requirements, assistance for new directors, ID&R, etc.
- Establish and host online Communities of Practice (CoP) discussion group sessions around various MEP/interstate coordination-related topics
- Support Annual Directors (ADM), CWG and other MEP-specific work group meetings




